PROPOSITION K: L.A. FOR KIDS PROGRAM 9TH FUNDING CYCLE REQUEST FOR PROPOSALS

ADDENDUM NO. 2

Issued September 23, 2015

Dear Prospective Proposer:

The Los Angeles City Council has reopened and extended the deadline to submit proposals for the Proposition K 9th Funding Cycle Request for Proposals (RFP) (which was originally released on January 29, 2015, and was modified by Addendum No. 1, issued on March 31, 2015). Consequently, this Addendum No. 2 is hereby issued for the Proposition K 9th Funding Cycle Request for Proposals to extend the deadline to submit proposals.

The new deadline to submit proposals is **3:00 p.m. on Tuesday, October 13, 2015**. Proposals must be **hand-delivered** to the Bureau of Engineering, Recreational and Cultural Facilities Division, 1149 South Broadway, Suite 860, Los Angeles, CA 90015.

Agencies that have already submitted their proposals prior to the original deadline are not required to resubmit their proposals. However, those agencies have the option to make revisions to their proposals, if they want to. To revise your proposal, you must pick up your previously submitted proposal at the office of the Bureau of Engineering Recreational and Cultural Facilities Division, between the hours of 9:00 a.m. and 4:00 p.m., Monday through Friday. If revisions are made to a previously submitted proposal, changes from the original submittal **must** be marked in red. This will help expedite review of the revised proposals that are submitted.

Any agency whose proposal or project was previously deemed non-responsive or ineligible, now has the opportunity to revise its proposal in order to bring the proposal or project into compliance with the requirements of the RFP.

Agencies submitting a new proposal or a revised proposal **must** submit: one (1) original proposal signed and embossed with the agency's seal, bound in a three ring binder and three (3) copies bound only with binder clips (for a total of four copies); and one (1) disk which contains a scanned (pdf) copy of the proposal.



Again, new or revised proposals must be received no later than **3:00 p.m. on Tuesday, October 13, 2015.**

As stated in the original RFP, a total of approximately \$16,954,435 will be made available in three funding categories for projects throughout the City in this 9th Funding Cycle. The three categories and funding amounts are:

1.	Aquatic Upgrades (Category 4)	\$4,588,051
2.	Lighting (Category 6)	\$6,586,496
3.	Acquisition of Parks/Natural Lands (Category 8)	\$5,779,888
	TOTAL	\$16,954,435

At its discretion, the City may increase or decrease the funding amounts for any of the three funding categories while still maintaining the approximate total funding amount of \$16,954,435.

All proposals are due by **3:00 p.m. on Tuesday, October 13, 2015.** All proposals must be hand-delivered and be received by the **Bureau of Engineering, Recreational and Cultural Facilities Division, Public Works Building, 1149 South Broadway, Suite 860, Los Angeles, CA 90015**, on or before the stated deadline. Proposals arriving after this deadline **will not** be accepted nor will they be considered for funding. A receipt acknowledging date and time of submission of all hand-delivered proposals will be provided by City staff. Mailed, faxed, or electronically transmitted proposals **will not** be accepted.

If you choose to deliver your proposal on **Tuesday, October 13, 2015**, please give yourself at least thirty minutes or more to get through the security check point for the Public Works Building. Being detained at the security check point **will not** be accepted as an excuse for not having your proposal in our office by **3:00 p.m.**
